Paving, building new roads beds, repair and or replacing grates, sidewalks and curbing. Restriping roadways and parking lots. Excavation, restoration and removal and replacement of light poles.

**Assessing Official Comments:**

QUALITY: Argenio is a professional company in all respects. They always meet and or exceeded the requirement and the work is beyond reproach.

For example:

1. They repaired downspouts and storm drains at Bldg. 621 which was not in the contract.
2. They repaired curbing behind Bldg. 600 which was not in their contract.
3. They installed new concrete steps at Arvin Gym which was not in their contract.
4. They installed conduit under sidewalk at Kosciusko Monument which was not in their contract.

In addition, they spent many days measuring areas to be contracted that never were. They spent many man-hours and resources repairing an asphalt/concrete joint on Cullum Road to make sure that it was an exceptional product. They provided the COR with daily manpower and progress updates. They kept to their schedules and always provided upfront communication that made the jobs more successful. They were always professional, informative, and went above and beyond to accommodate the unique requirements of the USMA.

SCHEDULE: Argenio Bros. always met or exceeded the schedule per each Task Order. During all phases of each Task Order they kept to the schedule and kept the COR informed as to status. Their efforts helped to minimize delays on roads when work was being accomplished. This further helped West Point DPW Master Planning and Facilities to schedule minimize delays and keep other projects from being delayed due to Argenio delays.

MANAGEMENT: Argenio Bros. management have always been proactive and kept the COR informed as to all aspects of each Task Order. They spent many man-hours and resources repairing an asphalt/concrete joint on Cullum Road to make sure that it was an exceptional product.
